The Administration & Finance minutes state:

"It was agreed council should be advised that A&F recommends Notice be given to both the play school and UCAS subsequent to the AGM of June 4,2023 and prior to the end of June 2023."

Al questioned why we would give 12 months' notice to UCAS when the partnership agreement requires 6 months' notice. The play school contract requires 12 months' notice so notice in June is necessary. Kent commented that our obligation to UCAS is 6 months' notice. Al suggested that it is not known at this time whether this building will be sold or kept so it is premature to give notice to UCAS in June.

5.3 Vice President's Report

VICE PRESIDENT'S REPORT April 19, 2023

- March 25/23 Helped with the downtown lunch program at the Baptist Church. We served about 126 guests. They had to turn away 5 as the food was all gone.
- March 26/23 Wesley Annual Fiscal Meeting Budget passed. It included revenue from Blueberry Sale so someone will need to make that, or a comparable fundraiser happen.

- March 26/23 First meeting of the Wesley portion of the implementation team.
- March 29/23 Darwin Roske (Property), Jim Gunningham (Trustees), Rev. Carolyn Woodall and I met with Edward Archibald and Doug Doulan to hear their ideas for the development of the property. They are based in Regina and have a much clearer understanding of the local building environment than Kindred Works displayed. They have made personal connections in the city and have ideas how to make a project palatable to the neighbourhood. In their plan our building would be demolished. They suggested if we wanted the building kept, we should sell it to another church as the value to them was the land not the building. They promised to have a proposal for council's consideration at no cost to us for the meeting April 19/23.
- March 31/23 promoted, organized, and attended Games Night. 8
 people in attendance. No one from Sunset came so perhaps it is time to discontinue this event for the time being and re-think it in the fall.
- April 12/23 First joint meeting of the Amalgamation Implementation
 Team. It is going to be a dynamic group. A communication about our discussions was send to membership of both churches to be included in the email announcements and also to be posted on the bulletin boards.

 One of the main goals is to keep everyone informed of our activity. The

- details of many specific functions/committees will be delegated to those with hands on expertise in these areas.
- Nominations Brenda Patten agreed to be a representative to Regional Council, Moses Kanhai declined to be a Regional Council Representative.
 Paula Mills is considering being secretary but has not agreed yet. Leslie Beck has considered the role being Vice President but has declined as she has taken on a number of other volunteer jobs so did not feel she can give it the time needed. Do we really need a vice president in light of our unfolding future? Were each of the council committees able to bring names to our meeting on April 19/23 who will be able to work on joint committees? (ie. M&P, Pastoral Care, Christian Education)

Thu., April 13, 2023 *** 10:30 AM in person

1. CALL TO ORDER:

- a. **Attending:** Lenore, Karen, Glenn, Darwin , Jim and Reverend Carolyn
- 2. APPROVAL OF AGENDA: unanimous approval
- 3. MINUTES OF THE PREVIOUS MEETING (March 16 2023, 2023)

- a. Approval: Glenn / Lenore
- b. Business Arising:
 - A computer hard drive previously reported as missing may have been found. A hard drive has surfaced since the last meeting however it does not appear to have the information saved on it that the missing hard drive was supposed to have. It is unclear if the church had only one or perhaps two hard drives. Glenn agreed to search past accounting records to determine the number of hard drives actually purchased and report back.
 - Reverend Carolyn reported that Lee Stubbe had indicated he would do some updates to the church website however to date this has not been done. Darwin observed that the website continues to require several updates. This led to a discussion that the impending amalgamation may require some rethinking of staff job descriptions and responsibilities. To this end it was agreed that it would be appropriate for members of Admin & Finance to meet with M&P to review job descriptions going forward. It was also agreed that Glenn and Darwin would meet with M&P for this purpose and that Jim would issue the invitation on behalf of Admin & Finance. It is noted Darwin will be leaving town on April 23 and be away for much of May.

4. REPORTS

- a. **FINANCE & INVESTMENTS:** (Chernick, Schmuland)
 - Glenn reported the church's \$40,000 CEBA loan has been repaid since the
 previous Admin & Finance meeting. This repayment has reduced
 Wesley's cash position. Glenn feels that \$25,000 of funds in investments
 at Fiera Capital should be cashed in and placed in the credit union savings
 account to allow for the management of cash flow needs going forward.
 - Glenn advised that while projections are looking good now that he is concerned revenue projections could change quickly and feels that this fund transfer will allow for efficient cash flow management.

MOTION REQUIRED

That approval be provided for the transfer of \$25,000 from church investments with Fiera Capital to the church savings account at Affinity Credit Union.

Glenn presented the March 2023 financial statements for review.

MOTION REQUIRED

That March 2023 financial statements as prepared by Glenn Schmuland be accepted

b. VICE PRESIDENT (Bewcyk)

Discussion took place concerning what date would be appropriate to give Notice to the play school and to UCAS of termination of their lease and partnership agreement respectively. Lenore advised the AGM for the church will be held June 4 2023. There is no reason that both terminations could not coincide for the end of June 2024.

It was **agreed** council should be advised that A&F recommends Notice be given to both the play school and UCAS subsequent to the AGM of June 4,2023 and prior to the end of June 2023.

c. **PROPERTY & SERVICE:** (Roske)

- UCAS partnership Reverend Carolyn noted a meeting with UCAS has taken place involving the UCAS liaison committee during which a number of concerns raised by property convenor were raised.
- ii. Coming out of this meeting Reverend Carolyn indicated that UCAS reports the DOARC organization is under the umbrella of UCAS and may not be a new entity.
- iii. Darwin continues to be concerned that church insurance coverage may not be adequate without clarification of the status of DOARC. Should a letter of some statement be obtained that UCAS is responsible for DOARC insurance coverage?
- iv. At the time of the A&F meeting a letter to UCAS requested by council to be prepared by Kent Stuart had not yet been prepared.

I put a notice in the announcements and booked the church. Carolyn contacted February House.

- 3. Confirmation Retreat Carolyn had forwarded the announcement in Regional Rambler. The announcement and YAYAC newsletter (Thanks Kathleen)have been forwarded to all the families who have children in the age range. The CE Committee decided that we would pay the registration cost of \$50 for each youth and \$25 towards travel to the event in Saskatoon. This information has been sent to the youth.
- 4. Glenn Schmuland notified me of an account with a balance of \$190.21. This money came from a Change for Change Sunday School project, Youth tips from Mens Club and a donation from Jacob Jaleta for Food for Hungry. 5.10 WUC/UCAS Liaison Committee

UCAS/WUC Liaison Committee Report to Council April 19, 2023

Christine, John, Kent Carolyn, James, Wilma, Elaine

The Committee met of March 20, 2023

- 1. Christine reported that UCAS has amended its name to UCAS & African Descent Professional Associates. In discussion, we are advised the corporate amendment is the same as the original Uganda Canadian Association of Saskatchewan (UCAS) Incorporation and represents an updated incorporation and not a new entity. We are advised that it will not affect the terms outlined in the Partnership Agreement. It may require an Addendum to the Partnership Agreement reflecting this change.
- 2. Kent reviewed the current situation in relation to the future of Wesley. At the congregational meeting of March 5, a resolution was passed in support of moving forward with plans to develop a MOU with Sunset United outlining the path forward to shared services/amalgamation. It is anticipated that in September, WUC

will be worshiping at Sunset. There are no decisions concerning the future of the building.

- 3. Christine reported the ongoing renovations to library/office and Room 105 are almost complete. New furniture has been purchased, some has yet to arrive. A special thank you was extended to Darwin Roske for all his assistance in overseeing the work.
- 4. There was discussion about issues brought forward to Council by the Property Convenor of Administration and Finance concerning the status of Daughters of Africa and particularly their use of the building. In accordance with *Article 7* of the Partnership Agreement Re: Conflict with Respect to Use of the Building, the Chair will forward a written description of the issues so UCAS has the opportunity to provide a written response.
- 5. There was discussion that focused on the UCAS partners sense that they do not feel welcome at Wesley. Despite ongoing efforts to support and embrace the intent of the Partnership, there appears to be an ongoing environment of negativity/criticism, which causes discomfort, and distress. Staff feel uncomfortable when working at Wesley fearing negative encounters with staff or volunteers; "we walk on eggshells, we avoid interactions with the office, we feel we can do nothing right." This is an ongoing concern.
