Report of the IIM to Wesley Church Council March 23, 2023 Liturgically, we moved into Lent this past month. We had communion on Lent 1 with members of Sunset United joining us for that occasion. The A-Team led worship when I was away on March 19th. Everyone enjoyed the P.I.E. focus and the pie afterwards.

In programming, we held a very informative evening event on February 24th in recognition of the ongoing aggression of Russia against Ukraine. It was an honour to be the MC for the Annual, and for Dr. Becca Whitla the inaugural, Gruchy Lecture at St. Andrew's College on March 1st. We planned and prepared for Messy Church for March 3rd. Though we had no children with their families arrive, the volunteers had a lovely craft time and supper, before others joined us for Games Night with Sunset folk. We began a new book for our study group and have had some different people join us, as well as our regulars. I attended the National Church's AFFIRM webinar in honour of P.I.E. - We have been advised that effective January 10, 2023, in accordance with *The Non-Profit Corporations Act, 1995* Uganda Canadian Association of Saskatchewan (UCAS) name has been amended to UCAS & African Descent Professional Associates Incorporated. This incorporation is the same as the 1990 UCAS incorporation entity and as such, it an update and not a new entity.
- 2. Renovations to the library and 105 have been completed. Additional work was required including adding shelves in the storage unit in 105, putting ventilation into the storage unit. UCAS has moved back into the office and library space. A mobile whiteboard, new chairs and tables have been received and are now stored in 105. New chairs have been purchased and located in the kitchen lounge. A two-way deadbolt has bee installed on the door between the WUC Office and UCAS office.
